This Extended Guarantee is an addition to, and does not in any way affect, any statutory or other rights of the purchaser.
2. The Panasonic standard product guarantee period for Photovoltaic module is 15 years from date of purchase of the Product by its Ultimate customer. The Extended Guarantee shall be applicable for Photovoltaic module HIT® 25 years from date of purchase of the Product by its Ultimate customer ("Extended Guarantee period"). The Guarantee is applicable to the original purchaser only. When module(s) remain at their original installed location this guarantee is transferable to any subsequent owner of the location, or subsequent title-holder of the Module(s) upon satisfactory proof of succession or assignment. It is a condition of this Extended Guarantee that the original sales receipt of the Product and the original Guarantee extension certificate, are presented showing the date of purchase. In order to be valid, the Extended Guarantee must be activated by sending the filled application form to Panasonic (info.solar@eu.panasonic.com) within 90 days of purchase.
